### TERMS AND CONDITIONS

Please read the terms and conditions of admission outlined below. By submitting your application for admission you agree to abide by these terms and conditions.

#### I. REGISTRATION AND ADMISSION:

- 1) Applicants must meet Eligibility Criteria for the Course applied for.
- 2) Eligible applicants must submit Application Form along with requisite fee and all supporting documents.
- 3) Admission shall be confirmed subject to submission of all the required documents and payment of Registration fees (Minimum Rs. 2,000).
- 4) In the event of any information or document submitted by the Applicant being found to be incorrect or misleading, **ACMR** reserves the right to cancel Admission of the candidate without any fee refund.
- 5) In case the student wishes to pursue a Course other than the one for which Admission was taken, he/she can do so by giving a written request to the Management. However, this option is available only within 15 days from the date of Commencement for Course initially applied for.
- 6) **ACMR** reserves the right to reject any application without giving any reason.

#### II. FEE:

- 1) Registration and Course fee is non-refundable under all circumstances.
- 2) All Course Fee must be paid in full, or in the case of any installment plan the agreed installment payment, prior to the start of the Course. In the event that the installment plan is not being paid as per the agreed schedule, **ACMR** reserves the right to have the student withdraw from the Course.
- 3) **ACMR** reserves the right to revise the fee pursuant to any changes in Government taxes or other applicable laws or under any extra-ordinary circumstances.
- 4) In case of late payment of fees, late payment charges will apply as per the policy in place.
- 5) Students shall not be allowed to attend any class or appear for examination if the requisite Course fee is not paid.

#### III. CANCELLATION OF COURSE:

**ACMR** reserves the right to withdraw or cancel any Course before commencement of the batch. In such an event, student may be offered another course run by **ACMR** or a refund of fee paid.

#### IV. MISCONDUCT AND DISCIPLINARY ACTION:

##### A. Serious Misconduct:

Indulgence in the following practices shall constitute serious misconduct

and student may be expelled and his admission terminated from the Institute without any warning:

- 1) Physical/Sexual assault or threat of Physical/Sexual assault against any fellow student, or member of the teaching or non-teaching staff of **ACMR**.
- 2) Willful destruction of **ACMR** property.
- 3) Causing disruption of the normal functioning of **ACMR**.
- 4) Carrying, using, or threatening to use any weapon or firearm.
- 5) Ragging.
- 6) Chewing tobacco/smoking/drugs/alcohol intake within the Institute premises
- 7) Unlawful harassment of whatsoever nature.
- 8) Plagiarizing/cheating in examinations/assignments
- 9) Discrimination on the basis of religion, caste, gender, race or any other unlawful ground etc.
- 10) Indulging in acts which bring disrepute to other students, faculty or **ACMR**.
- 11) Entering into contracts by misrepresentation.

##### B. Minor Misconduct:

Indulgence in the following practices shall constitute minor misconduct and student shall be issued Warning Letter which will be followed by termination in case of no improvement:

- 1) Failure to comply with the policies and procedures of **ACMR**.
- 2) Failure to maintain satisfactory academic progress.
- 3) Absent in exam without prior intimation.
- 4) Absconding (i.e. absent without information in writing)
- 5) Non-completion of assignments given by trainer in due time.
- 6) Misbehavior/unprofessional behavior in class.
- 7) Disobedience of Instructions of Trainer or Management.
- 8) Non-adherence to Grooming & Dress Code Policy.
- 9) Non-serious attitude in class.
- 10) Refusal to Identity of one's self when requested by authorized **ACMR** officials.
- 11) Unauthorized access and use of **ACMR** property and facilities.

##### V. THEFT, LOSS / DAMAGE TO **ACMR** PROPERTY:

Student agrees to compensate **ACMR** against any loss or damage caused to **ACMR** property due to his/her willful act or carelessness or negligence.

##### VI. ABUSE OF ELECTRONIC COMMUNICATION:

The following shall amount to abuse of electronic communication:

- 1) Using Institute's or personal telecommunication or data communication networks for illegal or improper use.
- 2) Taking or sharing photographs/videos/audios without Management's permission.

#### VII. MEDIA CONTACTS:

Students are expressly prohibited from speaking on behalf of, or for ACMR with any media organization or publication or from inviting the same to any ACMR Centers.

#### VIII. PROHIBITED ITEMS:

Students are not permitted to use, sale, distribute, dispense or bring or carry into ACMR's property and premises any of the following items:

- Any intoxicants (alcohol, drugs, sedatives, barbiturates etc.)
- Weapons or firearms or explosives.
- Illegal chemical or biological agents.
- Other dangerous articles and substances which are injurious to persons or property.

#### IX. ATTENDANCE:

- 1) Minimum 70% attendance in classes is compulsory to become eligible to appear for Examinations.
- 2) Minimum 85% attendance during Clinical Internship is compulsory.
- 3) In case the attendance falls short, the student shall not be allowed to appear for the Examination(s).

#### X. EXAMINATIONS AND CERTIFICATIONS:

- 1) It is compulsory for the Student to appear for Weekly Assessments, Module Based Assessments, Final Foundation Exam and Pre-Internship Exam.
- 2) The Course Completion Certificate (ACMR) shall be awarded only after payment of full Course fee, passing the Pre-Internship Examination and Clinical Internship.
- 3) If the student fails to achieve the minimum qualifying marks, they shall be provided with an opportunity to appear for a Remediation Exam. However, a cost of Rs. 1500 per Remediation Exam would be charged for each such further exam.

#### XI. CLINICAL INTERNSHIP:

- 1) In order to qualify for Clinical Internship, the student must secure at least 70% marks in Pre-Internship Exam.
- 2) The Management will always endeavor to refer students for Clinical Internship in organizations based in nearby areas. However, specific requests from students for location preferences shall not be entertained by the Management.
- 3) During the Clinical Internship, the student shall be subject to the Rules and Regulations as are applicable to the organization where they are undergoing their Clinical Internship.

#### XII. PLACEMENT:

- 1) ACMR provides placement support to students who successfully complete the Course and does not guarantee placement to any student.
- 2) Only students who have completed Clinical Internship and Examination shall be eligible for placement support.
- 3) Placement support will be available for a period of 3 months from the end of Clinical internship.
- 4) Ultimate placement of the student depends on their performance in the course, interview and other factors. The decision to join any organization rests with the student and ACMR is not responsible for their finalization of salary, location or other employment terms.

#### XIII. DRESS CODE POLICY:

Maintaining a proper dress code is a key part of the training provided at ACMR. At all times students should be dressed in appropriate clothing. T-Shirts, Jeans and Sport shoes are not permitted.

#### XIV. JURISDICTION:

In case of any dispute the jurisdiction for legal proceedings will be PUNE (MH) Courts only.

#### XV. OTHERS:

Any matter not covered in this, the ACMR management decision shall be final.
